American Health Advantage of Mississippi (HMO I-SNP), offered by American Health Plan of MS, Inc., is a Health Maintenance Organization (HMO) with a Medicare contract. Enrollment in the American Health Advantage of Mississippi depends on contract renewal.

The benefit information provided is a summary of what we cover and what you pay. It does not list every service that we cover or list every limitation or exclusion. To join American Health Advantage of Mississippi you must be entitled to Medicare Part A, be enrolled in Medicare Part B and live in our service area. You must live in one of our network nursing homes, or live at home and Mississippi has certified that you need the type of care that is usually provided in a nursing home. Our service area includes the following Mississippi Counties: Bolivar, Calhoun, Carroll, Clay, DeSoto, Forrest, Grenada, Harrison, Hinds, Itawamba, Jackson, Jones, Lamar, Lauderdale, LeFlore, Madison, Marion, Marshall, Monroe, Oktibbeha, Pearl River, Rankin, Sunflower, Warren and Yazoo.

American Health Advantage of Mississippi has a network of doctors, hospitals, pharmacies, and other providers. If you use the providers that are not in our network, the plan may not pay for these services.

You must continue to pay your Medicare Part B premium.

This plan is an institutional special needs plan (I-SNP). Your ability to enroll will be based on verification that you, for 90 days or longer, have had or are expected to need the level of services provided in a long-term care (LTC) skilled nursing facility (SNF), a LTC nursing facility (NF), a SNF/NF, an intermediate care facility for individuals with intellectual disabilities (ICF/IDD), or an inpatient psychiatric facility.

This plan is an institutional special needs plan (I-SNP). Your ability to enroll will be based on verification that your condition makes it likely that either the length of stay or the need for an institutional level of care would be at least 90 days.

American Health Advantage of Mississippi (HMO I-SNP) has been approved by the National Committee for Quality Assurance (NCQA) to operate as a Special Needs Plan (SNP) until 12/31/2022 based on a review of the American Health Advantage of Mississippi Model of Care.

The pharmacy network, and/or provider network may change at any time. You will receive notice when necessary.

Out-of-network/noncontracted providers are under no obligation to treat members, except in emergency situations. Please call our customer service number or see your Evidence of Coverage for more information, including the cost-sharing that applies to out-of-network services.
